


Quarterly Statement on Retail Electric Providers pursuant to Section 3.07(d)(viii) of the Indenture, dated as of February 12, 2008, between CenterPoint Energy Transition Bond Company III, LLC (the “Issuer”) and Deutsche Bank Trust Company Americas, as Trustee (the “Indenture”)
